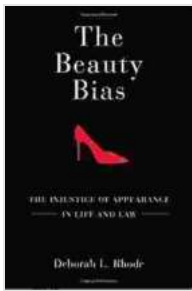

A study by the University of Florida found that mock jurors perceived attractive defendants as more credible than unattractive defendants, regardless of the evidence presented.***

***Appearance bias can also impact sentencing outcomes. A study by the University of Minnesota Law School found that defendants who were perceived as unattractive received longer sentences than those who were perceived as attractive, even after controlling for other factors such as criminal history."***

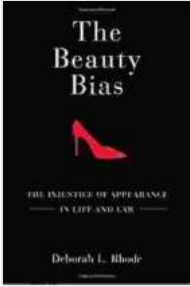
